

CORPORATE TRAVEL INSURANCE



If you, or your employees engage in international or domestic business travel you need to consider this policy.

Corporate travel insurance covers expenses for such things as medical treatments, emergency evacuations, flight cancellations, lost luggage and more - without many of the usual restrictions and exclusions placed on regular travel policies.

FEATURES:

- Covers **directors** and **employees**.
- Extends to cover the **personal travel** of the directors, accompanying spouse and dependent children.
- **Pre-Existing Medical Conditions are included** if at the time of departure the person is fit to travel following confirmation from a Medical Practitioner. Most policies exclude pre-existing Medical Conditions unless applied for and an extra premium is paid*.
- Covers expenses for such things as **medical treatments**, emergency **evacuations**, flight **cancellations** and lost **luggage**.
- **Nil excess** (excepting \$250 on Electronic Equipment only)

CONDITIONS:

- Travel radius for business travel is 50km's and 250km's for leisure travel
- Travel must be at least 50% business related unless approved by the insurer
- Any trips over 60 days in length must be approved by the insurer
